WHERE DOES YOUR PAPER COME FROM?

INTERNATIONAL PAPER

We all know paper is made from trees, and trees come from forests. But let's be more specific. Which forests? If your paper comes from the right forests, you can be part of a sustainable solution that benefits people and nature alike.

If you care about the environment and want future generations to have the same opportunities that we have, you support sustainability. You want products that are made in a way that can be sustained indefinitely without doing harm. You want paper that comes from a company that ensures forestlands are managed responsibly. Better yet, you want paper that is third-party certified.

But not all paper is certified sustainable. In fact, less than 10% of the world's forests are third-party certified. That seemingly puts a lot of demand on a relatively small resource. Fortunately, if we broaden our understanding of the paper industry as a whole and paper certification in particular, we'll find that it isn't that hard to buy paper we can feel good about.

Here's what you can do:

## CONSIDER **ALL**CREDIBLE CERTIFICATIONS

Certification in the forestry and paper industry is a growing trend, and credible certification comes from several organizations in North America, including the Sustainable Forestry Initiative® (SFI®), the Forest Stewardship Council (FSC®), the American Tree Farm System® (ATFS), and the Programme for the Endorsement of Forest Certification (PEFC®). These third-party experts set standards and work with an accredited organization to verify a paper company's performance, much as a financial audit verifies a company's financial performance. Their chain-of-custody certification indicates that every phase, from planting and harvesting to transportation and production to sale, has been carried out in a sustainable fashion.









In the U.S., only 12.5% of forests are certified. SFI-certified forests make up most of that number (45%), followed by ATFS (30%), FSC (12.5%), and SFI/FSC dual-certified (12.5%).

### **DOWN TO EARTH INSIGHT**

Don't get hung up on one certification system. Multiple routes to certification have led to improved standards and more options for obtaining certified products. This availability keeps costs down. All third-party certifications are helping to ensure that more and more forests are being properly managed for the future.



# LOOK **BEYOND**CERTIFICATION

Although certification is important, it is but one way to measure the behavior of paper companies and their commitment to environmental issues. After all, protection of the forests is necessary for the continued production of pulp and wood products.

International Paper, for example, has been practicing sustainable forestry for more than a century, developing strong partnerships with family forest owners, state and federal agencies, and conservation groups. Here are some facts that shed light on the paper industry's commitment to environmental stewardship and the effects it has had on our forests here in the U.S.

- Today the U.S. has 750 million acres of forestland.
- There are 12 million more acres of forest in the U.S. today than there were 20 years ago.
- Forest inventory, the number of trees still standing after mortality and harvesting, increased by 49% between 1953 and 2006.
- Every day more than 1.7 million trees are planted in the U.S.—
   4 trees per person per year.

You know that trees make paper, but paper also makes trees. The demand for paper drives growth of the forests. That's the beauty of a renewable resource. It's important to buy from a company with a demonstrated commitment to environmental stewardship.



# **CONSIDER**THE ALTERNATIVE

You've seen it over and over. Pay your bills via the Internet. Help save a tree by receiving your statements online. What if we really did become a paperless society? It's not likely or even desirable. Consider this: Landowners face pressure from development and other land uses all the time. Would you rather see more trees or more shopping malls?

Managed forests help clean the air we breathe, provide habitat for a wide range of wildlife, and offer unmatched recreational opportunities for families who like to hike, fish, camp, and study nature. Managed forests do all this and provide the pulp we need for paper and packaging. Is there a better use for land?

- For every 50 tons of paper used, one acre of forestland is sustainably managed.
- An acre of young, healthy trees will produce 4,280 lbs. of oxygen and capture 5,880 lbs. of carbon dioxide from the atmosphere each year.

The icing on the cake is that **most paper fiber is reusable.** Every day the paper industry recycles enough paper to fill a 15-mile-long train.

### **DOWN TO EARTH INSIGHT**

Properly managed forests are an asset we can all appreciate. Combine the renewable nature of trees and the reusable nature of paper, and you have a powerful combination that ensures there will be plenty of paper—and plenty of nature—for future generations.
